## **Annuity Options**

### **Immediate Payment Gift Annuity:**

- **Single-Life Gift Annuity** – This agreement would make payments to you or a designated individual. The rates for this option are listed on the reverse of this card.
- **Two-Life Gift Annuity** – In this agreement you may choose a second individual—spouse, child, friend, etc.—to whom the payments would continue after your death. This option, however, pays a reduced rate. Please contact us for a rate quote.

### **Deferred Payment Gift Annuity:**

If you prefer to start receiving payments at a later date, usually the rate will be higher. Please contact us for a rate quote.

### **Flexible Deferred Gift Annuity:**

Another option with a deferred gift annuity is to have a flexible date to begin receiving payments, as opposed to a fixed date with a standard deferred gift annuity. Again, please contact us for a rate quote.
