Why automated giving?

Automated giving is a convenience many people choose as a way to regularly support BGEA's ministry without having to constantly repeat the steps of submitting a donation. This not only saves you time and postage but also allows more of your gift to go directly into sharing the Gospel.

Are there other benefits?

When you set up automated giving, you will receive a complimentary book or resource each time we offer one as a thank-you to our ministry partners.

Is there a minimum monthly donation for EFT/recurring credit card gifts?

No, your monthly gift of any size will help proclaim the Good News of Jesus Christ around the world.

Can I change or discontinue my automatic giving after it has been established?

Yes, simply write or call us and then allow 10 days for us to process your request.

How do I know my sensitive account information will be kept secure?

BGEA values your partnership in seeing lives transformed by the Gospel, and we consider it our responsibility before God to keep your confidential information protected. To honor this great responsibility, we work with our financial institution to ensure we meet or exceed industry security standards.

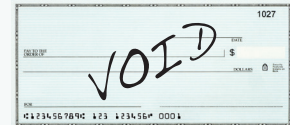
